Attendance at Pi Kappa Phi College in January 2017 by appropriate officers. Revise Risk Management Procedures and By-Laws, including writing a prevention plan, which would ensure an alcohol free recruitment. Meet with Pi Kappa Phi's Leadership Consultant as prescribed by Pi Kappa Phi Headquarters. First recruitment violation from IFC resulting in a \$500 fine.

Sigma Alpha Epsilon	Hazing	In Violation	Suspension in abeyance through January 2018. All members involved in the incident must have their membership status reviewed and appropriate sanctions levied against them. Chapter Redevelopment Plan in place from Sigma Alpha Epsilon Headquarters which involves monthly visits by headquarters and/or regional staff/volunteers to check progress on identified goals and action items. Chapter President and New Member Educator must meet regularly with assigned FSL Chapter Coach. Chapter President must attend 2017 Presidents' Retreat. All appropriate chapter representatives must attend TCU FSL Officer Training Day. FSL Staff Members will be present at New Member Activities and Events.
Sigma Chi	Violation of Alcohol, Risk Management, Event Hosting, and Recruitment policies	In Violation	Probation through December 31, 2016. Host an educational speaker from Headquarters to speak with executive board and general chapter about proper risk management. Thorough assessment of chapter financial records to ensure proper checks and balances are in place to prevent future unauthorized use of chapter funds. Individual members responsible for this incident were also held accountable through chapter proceedings. First Recruitment Violation from IFC resulting in a \$500 fine.
Sigma Nu	Hazing	Not in Violation	Follow all recommendations from Sigma Nu Headquarters, Chapter President and New Member Educator must meet regularly with FSL Staff members throughout the Spring 2017 semester. Chapter President must attend 2017 Presidents' Retreat. Appropriate representatives must attend TCU FSL Officer Training Day. FSL Staff Members will active participate in New Member Meeting and Events over the next two new member periods. Any member sanctioned by Sigma Nu will also be referred to Campus Life for follow-up.
Sigma Phi Epsilon	Violation of Alcohol, Risk Management, Event Hosting, and Recruitment policies	Not in Violation	Chapter leadership to engage in additional education about event hosting, risk management, and alcohol. Fraternity will host their regional director who will provide further education. Chapter will write new policies to provide sanctioning for any member found responsible for hosting an off-campus social event. Individual members responsible for this incident were placed on internal social probation by the fraternity.
Sigma Phi Epsilon	Hazing	Not in Violation	Chapter must rewrite the plans for Big/Little Reveal. Chapter must rewrite with Sigma Phi Epsilon Headquarters staff an appropriate week-by-week Sigma (new member) process. Chapter must reallocate funds in order to spend more on member development. Chapter leadership must work with Fraternity and Sorority Life staff to receive ongoing coaching related to chapter operations and new member education.
