TCU PD, IFC, and FSL should be notified of the event at least 2 weeks in advance and invited to attend the workshop. The attendance list from the workshop should be emailed to the IFC Advisor and the Director of Fraternity and Sorority Life. Eta Chi will present a summary of the risk management workshop at an IFC Presidents meeting no later than October 22, 2022. • Eta Chi will work with Pi Kappa Phi headquarters staff, alumni, and advisors to host a program that will educate active members on national policies/guidelines around what constitutes a chapter event. This workshop must be completed by October 22, 2022. At least 85% of members must be in attendance. The attendance list from the workshop should be emailed to the IFC Advisor, and the Director of Fraternity and Sorority Life.
